Prince George's County Winter Storm Road and Transportation Status Update – Tuesday, January 27, 2026

Primary and Secondary Roads 100% Passable as Snow Operations Continue in Residential Neighborhoods

Residential Neighborhoods 50% passable

Residents May Now Submit PGC 311 Snow-Related Service Requests

FORESTVILLE, MD - The Prince George's County Department of Public Works and Transportation (DPW&T) announced today that 100% of primary and secondary roads in the County and 50% of residential roads are "passable." This is a significant step in the County's snow response efforts, following the recent snowfall and below-freezing temperatures that are expected to continue.

Passable conditions allow a passenger vehicle to negotiate a single travel path using reasonable care. This usually means the road has been plowed and reasonably level but may still be snow and/or ice-covered.

Active precipitation in the County ended early Monday, and snow crews moved into residential neighborhoods the same day. This work will continue around the clock until all roads are plowed to complete condition.

"Our crews have been working around the clock, in very challenging conditions, to make sure our roads are safe and passable," said DPW&T Director Michael Johnson. "This is detailed, time-sensitive work, and we are committed to finishing every neighborhood safely and thoroughly."

What Residents Can Do

Residents can support snow operations by:

- Moving vehicles off residential streets when possible, or to the EVEN side of the road.
- Shoveling snow after streets have been plowed to avoid driveways being blocked by snow operations.
- Shoveling sidewalks abutting single-family homes and businesses, as required by the County Code/Abutter's Ordinance.

Beginning today, residents may submit snow-related service requests through PGC 311.

DPW&T will continue to provide updates as snow removal progress continues.

DPW&T will continue to monitor route conditions and make service adjustments as needed. Residents may experience delays. Residents are urged to exercise caution when accessing transit equipment and facilities, as sidewalks may be coated with snow and ice, causing slippery conditions.
