The Chair also asked about a Feb 6<sup>th</sup> letter to the State regarding 508 funding and how the Fire Chief is controlling the 508 Funds, when the Fire Commission has a committee that makes the determination for funding. The Association President asked the Chair to clarify that the Fire Chief has no say in the 508 funding, the Chair confirmed that was the case.

#### Questions from the floor:

- -Dottie Burket asked about the Ladies Auxiliary new office space and where they could be housed. The Chair advised that a location has not been determined.
- -Brian Lau asked about the increased of LOSAP benefit increase, the Chair advised the Voce-Chair is working on a proposal to reduce the LOSAP benefit age and to increase the payments. Also asked about the death benefit being tax exempt, Chair advised he would look into it. Also asked about recruitment that was discussed at the last Commission meeting, asked if there was an analysis about attrition rate for applicants, and for the Co. 30 and other companies needing more volunteers. The Chair advised there were over 500 applicants processed last year issue there were some internal issues such as applicants not showing for physicals and such. The recruiter also advised that there was never a system in place to be able to report out those metrics, and was the reason that ApplicantStack was purchased. In the future this type of data should be able to be processed.
