Vendors can begin setting up at 8:30 a.m. but **MUST** arrive and be set up no later than 10:30 a.m. The main entrance and loading area will be closed off beginning at 10:30 a.m. for pedestrian-only traffic. **This will be strictly enforced.** Late arrivals may forfeit their booth space. Vendors must stay for the duration of the event. One table and two chairs will be provided per vendor (not applicable to food truck vendors). Canopies no larger than 10' x 10' are welcome (weights to secure tent canopies are suggested). Electricity sources will not be available for this outside event.

### Cancellations and Vendor Fees

The Department of the Environment has the right to cancel the Green Festival at any time and shall not be held liable for damages, claims, expenses, or losses because of the cancellation. We extend our gratitude for the partners helping make this a success. There are no fees associated with participating in the event.

### Liability

The applicant agrees to hold harmless and indemnify Prince George's County government, and its officers, employees and agents from and against any and all liability, claims, actions, causes of action, suits, demands, losses, damages, judgements, expenses and costs, including reasonable attorneys' fees, arising from any accident or occurrence causing injury or damage to any person or property, including any claim for injury to or the sickness or death of any person or persons (including applicant/vendor's employees or property) relating or attributed to the Prince George's County government's authorization for the applicant/vendor to sell food products at the Prince George's County Green Festival.
