OPEN SESSION

I. OPENING OF MEETING

The Board Chair, Cassandra Burckhalter, opened the meeting at approximately 5:04 pm and welcomed all in attendance. There was a quorum present with four (4) Board Members. The meeting was held in-person and virtual, Microsoft Teams.

II. GENERAL BUSINESS AND ADMINISTRATIVE MATTERS

The four (4) Board of Ethics (Board) Members in attendance approved the agenda, by a vote of 4-0.

The four (4) Board of Ethics (Board) Members in attendance approved the Meeting Minutes for October 21, 2022, with one (1) edit, by a vote of 4-0.

III. BOARD CHAIR REPORT

In recognition and appreciation of Robin Barnes-Shell, the Chair and board members thanked her for 8 years of dedicated service to the Prince George's County Board of Ethics.

IV. EXECUTIVE DIRECTOR REPORT

The Executive Director informed the Board of the following Office of Ethics and Accountability (OEA) compliance activities: to date, there were seven (7) board removal letters pertaining to delinquent non-filers who filed late, without payment of late fees for Financial Disclosure Statements, with a total of nine (9) board removal letters for Financial Disclosure Statements; and fifty-nine (59) registered lobbyist registrations and one (1) terminated.

The Executive Director informed the Board that the Office of Human Resources Management (OHRM) will continue to collaborate with OEA to provide zoom meetings to conduct Ethics trainings to Board and Commissions.

The Executive Director informed the Board that the lobbyist registrations were updated on the OEA webpage.

The Executive Director informed the Board that the vacant Investigation II position in OEA will be advertised and available for viewing on various platforms.

The Executive Director informed the Board OEA needs a paralegal to assist the legal counsel.

The Executive Director informed the Board of the Open Meetings Act related to the Maryland Public Information Act (MPIA) requests.

The Board was provided the ethics advice table for October 2022, which summarized the informal ethics advice, information requests and legal advice provided by OEA.

The Board was provided with a case status report and updates on pending cases.

V. READING OF WRITTEN STATEMENT FOR CLOSING MEETING UNDER THE OPEN MEETING ACT

At 5:28 pm, a motion was made by Board Chair Cassandra Burckhalter and seconded by Board Member Sharon Theodore-Lewis to close the open portion of the meeting to comply with a specific constitutional, statutory or judicially imposed requirement that prevents public disclosure about a particular proceeding or matter and to consult with legal counsel.
