Appointments and Nominations Subcommittee:

The subcommittee will revisit and review the candidates for an interview for the Administrative Hearing Board (AHB).

The subcommittee plans to meet on Monday, September 15, 2025, to discuss evaluations and build a consensus on interview recommendations.

The subcommittee is concerned with potential biases related to certain credentials, so a discussion will be held to determine who should not be interviewed.

Cases and Complaints Subcommittee:

The subcommittee met to discuss the best approach to addressing case reviews, considering various ways to analyze the data.

The subcommittee is considering focusing on information from 2025 to make the review more concise and relevant.

The goal is to have a more targeted scope and come back with findings that may warrant further investigation.

Community Outreach Subcommittee:

Board Member Bryant discussed Blue Light Nights, which is a collaboration between Prince George's County Police Department and municipal law enforcement agencies to build positive relationships between police and the community.

The Board has been invited to join the community outreach portion of Blue Light Nights.

Board Member Jones has volunteered to give a presentation at the Division 3 and 8 coffee chat on Wednesday, October 1, 2025.

Faith and Blue is a national initiative promoting collaboration between law enforcement and faith-based organizations, with an event in Prince George's County from October 10th to 13th.
