Case Managers provide community-based support services to juvenile offenders who are residents of Prince George's County and have been referred by the Department of Juvenile Services. Bridges 2 Success aims to reduce risk factors and enhance protective factors associated with juvenile offenders who are at high risk of becoming victims or perpetrators of violence by providing linkage to community services and referrals for training and employment.

Tuberculosis (TB) Program staff meet regularly with patients with TB disease to watch them take their medications. This is called: Directly Observed Therapy, which is the standard treatment for all patients in Maryland with TB disease.

All Prince George's County residents are eligible for services if they:

- have been diagnosed with suspected or confirmed TB disease,
- have been in contact with a person with suspected or confirmed TB disease,
- have a positive TB test and need a chest x-ray or other related TB services
- are at high risk of developing TB infection or TB disease.
