Qualifications: To apply for a voter registration list, the applicant must sign a statement under penalty of perjury that the list is not intended to be used for purposes of commercial solicitation or any other purpose not related to the electoral process.

Application Deadline: Before any election, neither the State Administrator nor any election director may respond to an application for a voter registration list unless the application was filed on or before the advanced registration deadline. Applications received after that date shall be returned. (COMAR 33.03.02.05B)

Other Services: The Prince George's County Board of Elections allows the public to visit the office and view the most current Voter Registration History records electronically. There is a short form that must be filled out along with proper identification.

IMPORTANT REMINDERS

- If paying by cash, you must have the exact amount
- The applicant agrees to pay the remaining balance prior to receiving products
- There will be a \$35.00 assessment fee for return checks
- The standard time for processing a request is 10 business days
- Make check payable to: Prince George's County, Maryland
- Customer must pick up product within 10 days of notification that product is ready
- Agency will not be liable for products not picked up in a timely manner
- Please be advised that Voter Registration lists will **not** be transmitted via email. A link will be sent to access the file electronically.
