RESIDENTIAL DRIVEWAY PERMIT Submittal Checklist

A driveway permit is required for construction of driveway aprons in the public road R/W and for driveway parking pads on a private lot. This permit is required for repair, replacement, and installation of new driveways. This permit is not intended for commercial driveway entrances, which instead require a Street Construction Permit. This permit is not intended for new subdivision driveways, which instead require a Street Construction or Site Development Fine Grade Permit.

All applications, fee payments* and bond submittals are processed at the DPIE's Permit Center, 9400 Peppercorn Place, 1st Floor, Largo, Maryland 20774.

For Submittal of Permits with Paper Copies, Provide:

- FHLS or Plot Plan 2 copies
- All other documents 1 copy

Note: The permit shall expire 1 year from the date of issuance.

Note: For driveways within incorporated municipalities, the applicant needs to secure a driveway (DW) apron permit from the municipality if constructing a DW in the public road R/W. All other driveway aprons (in the public R/W) and driveway parking pads (on a private lot), require this permit. For driveway aprons located on state maintained roadways, a driveway/access permit is required from the State Highway Administration and a permit for the parking pad is required from DPIE if needed. Driveway aprons located on privately maintained roadways do not require driveway apron permits, however a permit for the parking is required from DPIE.

A. APPLICATION PROCESS – For the submission of application, the following items are required:

- □ 1. Filing fee of \$25.00
- □ 2. Completed permit application (one copy) This application form is available at the Department's Permit Center, 1st Floor, 9400 Peppercorn Place, Largo, Maryland
- □ 3. Final House Location Survey or Plot Plan with New Driveway Shown (2 copies) Plan to include existing conditions, proposed driveway and relevant dimensions

B. PERMIT ISSUANCE — For issuance of permit, the following items are required in advance:

- 1. **Permit fee**: Permit fee amounts are shown on page 2. If permittee has already paid \$25.00 filing fee, subtract that amount from this permit fee.
- 2. Bonds must be posted in the amounts listed on page 2. NOTE: Permittee will need to allow adequate time for the County's Office of Law to approve any bond instrument *other* than a cash bond. Bonds may be posted in the following forms:
 - Cash
 - Irrevocable letter of credit
 - Irrevocable assignment of funds or savings account
 - Corporate surety bond issued by an acceptable insurer, and/or
 - Certificate of Guaranty by the Development Guaranty Group of Prince Georges County Inc and/or Development Guaranty Group of Southern Maryland, Inc.

- B. PERMIT ISSUANCE For issuance of permit, the following items are required in advance: (continued)
- 3. **Approval** from DPIE's Site/Road Plan Review Division regarding the type of driveway.
- 4. **Approval** from M-NCPPC Permit Review Division if driveway parking pad (located on the private residential lot) is proposed.
