Introduction

Welcome to the Prince George's County Virtual Permit Café. Virtual Walkthrough permits are designed to be quickly obtained by customers in a virtual contact free environment. This user guide provides the basic steps involved in utilizing the Virtual Permit Center. It has been prepared as a general reference guide and is not intended to present every detail or situation of the process.

Applicant User Guide

Step 1: Complete your application in ePermits

An online application must be completed to begin the Virtual walkthrough process.

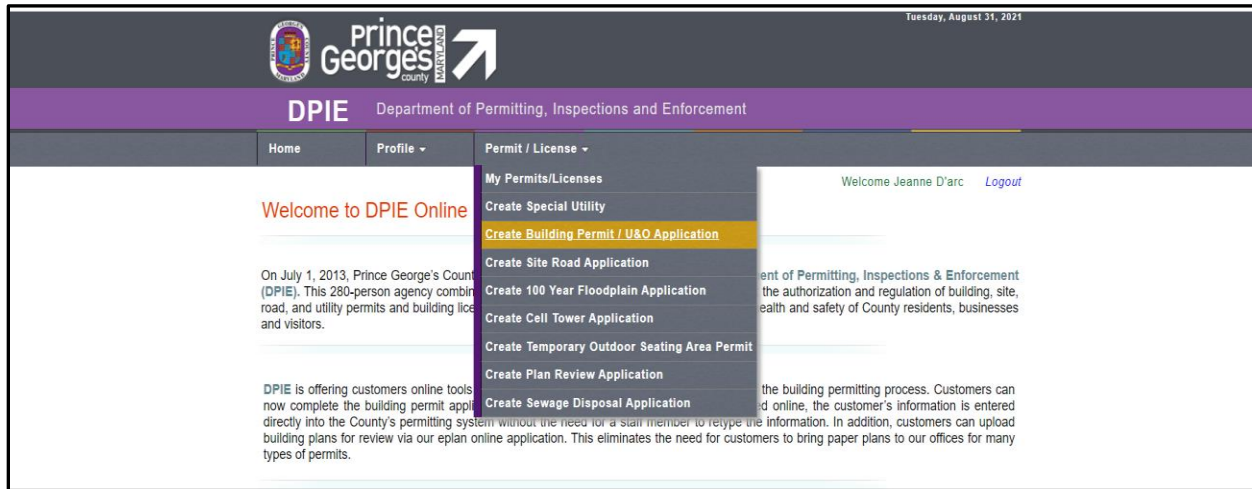

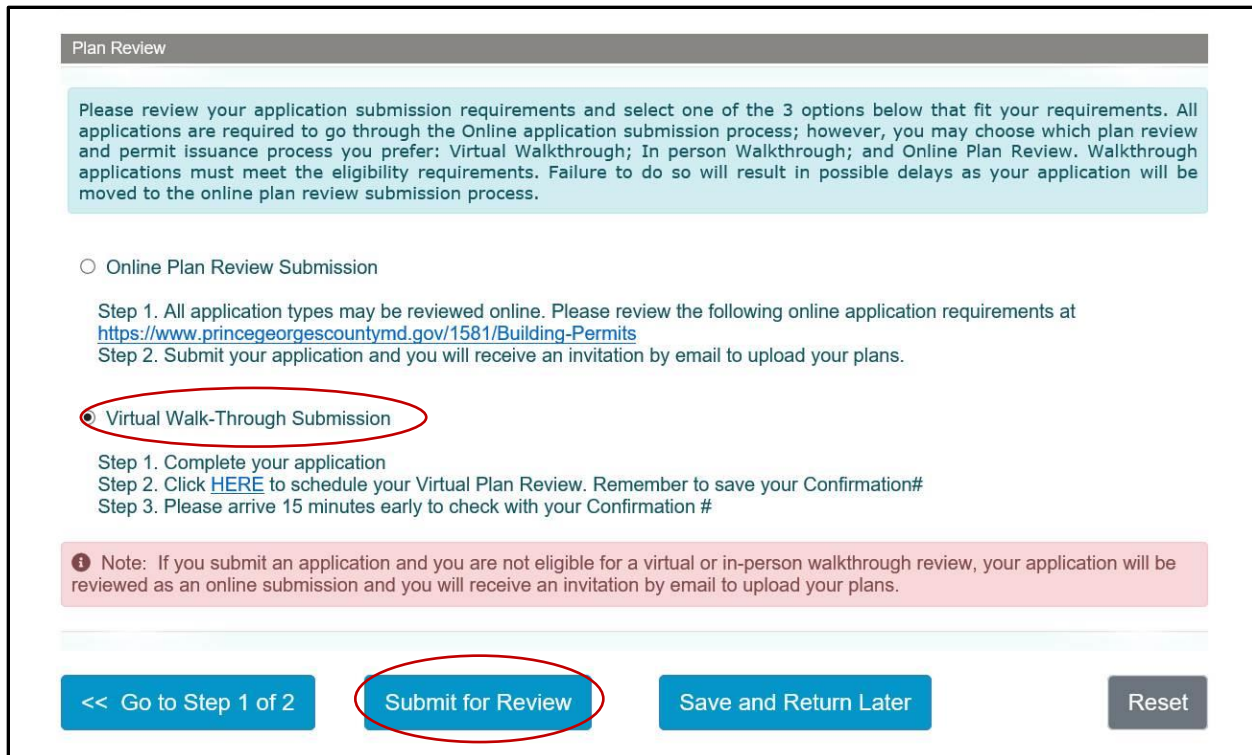

2. Select Create Building Permit and enter required information.



3. Select Virtual Walkthrough Submission.



4. Click Submit for Review.



5. You will need this application number to check in the Virtual Permit Café.

Step 2: Schedule an appointment

Once you have completed and submitted your online application and have checked the VPC option, you will need to schedule an appointment for your Virtual Review Session.

Once you have scheduled an appointment, an email and a text confirming your appointment will be sent to you. To prepare for your appointment, make sure to have ALL required permit documents available. Failure to do so may result in the appointment being rescheduled.

Note: You will need an electronic copy of your plans for review. Paper plans are not accepted.



Step 3: Applicant Self Check-In

Go to <https://virtualpermitcenter-checkin.princegeorgescountymd.gov/#/> and check in using the application number that you received from **ePermits** and use the Applicant email address that you used **to create your ePermits application**.

1. Upon successfully checking in, you will receive notifications by email and text to keep you updated as your application moves through each step in the process as shown below.

Welcome to the Virtual Permit Café. You will receive email and text notifications updating you on your application status. You must respond immediately to notifications or risk cancellation and must re-enter the Virtual Permit Café.

Your application is with the Permit Specialist. You are at #3 in the queue.

Example: you are at #3 in the queue means there are 2 applicants before you in the queue. You will receive notices as you move through the queue.

Your application is now with ePlan for Review. You are at #1 in the queue. You will receive an email with instructions to upload your documents. You have 15 minutes to upload into ePlan or you will be cancelled and must re-enter the Virtual Permit Café.



Step 4: Upload Drawings and Documents

After your application is processed, an ePlan invitation will be sent to your email address. The email will contain your login information, case number, and a project access link. Click on the “Project Access” link to enter the ePlan Login Screen. A sample invitation is shown below:

Step 5: Plan Screening

Plan Screening is a preliminary review of your uploaded documents in preparation for the formal review.

1. If your submission has met all requirements, your ePlan will move to the formal review stage. You will receive a notification as shown below:

2. On the other hand, if there are missing items or questions about your submittal, you will receive an email and text notification for the “**Applicant Re-Upload Task**”. After receiving the email, accept the task as previously instructed.



Step 6: Department Review

After your submittal is pre-screened for completeness, ePlan will enter the Department Review stage. At this time the County engineers will review your drawings.

1. You will receive notices as you move through the queue for each reviewer as shown below:

2. Expect to receive a request for a virtual meeting if a reviewer needs to speak with you as shown below:

Please make sure you have access to your device's camera and microphone before joining the meeting.

3. Click the meeting link to join the virtual meeting.
4. Some permits will require a final fee payment review. If a final fee is required, you will receive a corresponding task.



Step 7: Applicant Fee Payment

You will receive an email and text notifications for the “Applicant Fee Payment” task. A sample email and text are provided below:

To pay by cash or check in person:

1. Take your case number and payment to the DPIE office:
9400 Peppercorn Place Suite 100, Largo, Maryland 20774
2. Visit the Customer Service counter to obtain an invoice. Proceed to the cashier to make the payment.
3. Once you have paid the fee, click the [Project Access](#) link below.
4. Enter your user login and password.
5. Scroll to the bottom of the Projects screen. Your assigned task will appear in this section under the task column. (The task column will only appear once you have been assigned a task).
6. Click on Applicant Filing Fee Payment for your Project Name and accept the task. A new window with your task will open in your browser. (You will now have TWO windows open in your browser: a "Task" window and a "Projects" window. You will be required to continue working in both browser windows.)
7. Locate your open Task window in your browser.
8. Click on Submit to complete the task.

Your payment will now be confirmed for your ePlan review. Once payment confirmation is complete, your ePlan will proceed to Distribution for review.

1. Click the tab titled “Resources”.



2. Click "DPIE Online Payments".
3. Follow the instructions on how to pay the fees.

Step 8: Approved Plans and Permit

Once your plans have been electronically stamped by the County and any applicable fees have been paid, the ePlan process will conclude. You will then receive an email and text notification with instructions for downloading your approved plans and permit. The email notification will direct you to the folder that contains your stamped plans. Click on the drawing name (for example [Drawing1.pdf](#)) to open, and the stamps will be visible in red ink. A sample notification has been provided below:
